#### General terms of business

This contract shall base on the following provisions:

# I. Subject matter of the agreement

The wohnref erlangen offers all-round assistance services with regard to immigration, removal, or change of residence.

Legal assistance and tax consulting, the advice regarding insurance-dependent matters, and questions concerning the law governing the right of abode of foreigners including work permits cannot be furnished. If necessary, specialists can be designated on request with support of the professional organisations.

#### II. <u>Payment</u>

The payment shall depend on the pricelist according to catalogue valid at that time. This shall not apply to commissions already placed.

In the event of an early termination of a commission, the commission sum shall be payable in accordance with the extent of the efforts used until that time: 20 % on placing the order, 100 % on fulfilment. This shall not apply if the client shows proof that there was no or only a minor damage.

#### III. Client's duties

The client shall provide the wohnref erlangen complete information and documents necessary for the execution of the commission in due time. No costs may arise from it to the wohnref erlangen.

#### IV. Term of the contract; Termination

The client may terminate the commission at any time by means of a written statement given to the wohnref erlangen.

The wohnref erlangen may terminate the commission for cause; especially if the client shall significantly fail in its cooperation duties.

#### V. Offsetting

Only an undisputed or legal claim may be set off against a claim of the wohnref erlangen.

#### VI. <u>Liability</u>

The liability of the wohnref erlangen shall be limited on intent and gross negligence, provided that it is an essential contractual obligation, event of guaranteed features, delay, or impossibility. Liability shall be excluded in the event that an employee of the wohnref erlangen shall cause a damage far be from supposed or an unforeseen damage because of slight negligence.

Any information provided by a third party shall be passed on to the best of knowledge and belief. The wohnref erlangen may be liable for the correctness of such information only in the event of wilfulness or gross negligence.

Liability shall be exonerated with regard to oral or written translations. A contact to a sworn interpreter/translator can be made on request.

#### VII. Final provisions

Place of jurisdiction for any dispute arising in connection with this contract shall be the place of the registered office of the wohnref erlangen, provided that the client is a general merchant or has no general place of jurisdiction within the country.

Amendments and additions to this contract shall be in writing. Subsidiary parol agreements are not made. In the event that a provision of this contract shall be or become invalid, the validity of this contract shall not be affected. The void provision shall to be replaced by an agreement that satisfies the economic objective of the void provision with regard to the legal effectiveness or that comes closest to it. The same shall apply in the event of a loophole in the contract that needs to be filled.

The validity of other general terms of business is contradicted.
